Prothioconazole was not carcinogenic in lifetime feeding studies in rats and mice. Tebuconazole caused at high dose levels an increased incidence of tumours in mice in the following organ(s): Liver. The mechanism of tumour formation is not considered to be relevant to man.

**Assessment toxicity to reproduction**

Fludioxonil did not cause reproductive toxicity in a two-generation study in rats. Prothioconazole caused reproduction toxicity in a two-generation study in rats only at dose levels also toxic to the parent animals. The reproduction toxicity seen with Prothioconazole is related to parental toxicity. Tebuconazole caused reproduction toxicity in a two-generation study in rats only at dose levels also toxic to the parent animals. The reproduction toxicity seen with Tebuconazole is related to parental toxicity.

Tebuconazole caused an increased incidence of post implantation losses, an increased incidence of non-specific malformations.
